## **OLD BUSINESS:**

Linda Cook recommended a \$25.00 increase in the conference registration fee, tabled until the budget discussion.

- The biennial (every 2 years) Advanced Government Finance Institute Scholarship is now the annual GFOA Leadership Academy Scholarship, not to exceed \$4,000.
- The 2 Annual College Scholarships have been reduced to 1, due to lack of applicants despite being advertised in Peterson's College Scholarships database for years.
- The Board approved the addition of (1) Level II Certified Finance Officer Scholarship, up to the total cost of the certification. Must already have earned Level I Certified Finance Officer.

Technical Resources – Anna Payne added that Gina our part time administrative position resigned. At this time we will not need to replace the position. I will keep the board notified if any changes need to be made.

Budget Review & Finalization for Nov. 2018 to Oct. 2019 was adopted in the amount of \$370,082.85.

#### **COMMITTEE REPORTS:**

Annual Conference: Conference Dates are Sept. 29<sup>th</sup> thru Oct. 2, 2019 in Savannah. I just want to thank the board for increasing the registration fee, it will help with the budget.

Career Development: We have had a lot of participation with the webinars, but it is hard to tell exactly how many people are benefiting from them. For example, one person registers and several people watch the webinar on 1 payment. We will continue to have great webinars. The cost of the webinars are \$1,500 @ 6 a year.

Communications: The newsletter will go out this month.

Membership: We have 766 total members, 659 active – 105 associates – 1 educator – 1 retiree. We will need the membership updated on the website.

Scholarship/Awards: The 3 members that have unused scholarship funds, will be rolled over to Level II.
